GROUND REGULATIONS OF THE HUNGARIAN FOOTBALL FEDERATION (MLSZ) FOR SPORTS EVENTS ORGANISED BY MLSZ

1. By buying a ticket or a season ticket or by collecting another certificate for admission, as well as by turning up for admission, the participant of the sports event acknowledges to be bound by the Ground Regulations. In addition to the Ground Regulations the participant shall comply with the requirements specified by the organiser, as well as the instructions of the organiser, the police and the security staff, the requests of the stewards.

2. A participant can be admitted to and can stay at the venue of the sports event provided:

- **2.1.** he agrees to prove his personal identity when asked to do so by the security staff, and
- 2.2. he possesses a valid ticket, season ticket or other entry permit, and if he is a Hungarian citizen

 and according to the preliminary information attending a certain match so requires he possesses a club or football card;
- **2.3.** he is not banned from attending sports events, or is not subject to exclusion or a banning order due to an offence and is not subject to a decision of a foreign sports organisation, authority or court with a similar effect, referred to in Section 76/A(1) of Act I of 2004 on Sport (hereinafter referred to as the Sports Act).
- **2.4.** in the case of a personal notification during the control the personal details shown on the ticket, season ticket, club card or on the entry permit match the details shown in the person's document suitable for personal identification;
- **2.5.** he is not visibly under the influence of alcohol, drugs or any other intoxicating substances;
- **2.6.** he consents to the inspection of his clothing and belongings, the size of his belongings shall not exceed the size of 30x40x20 cm.
- **2.7.** he is not carrying
 - any food, drinks, drugs, any objects that are difficult to handle and cannot be stowed under the seat, or objects that can compromise the running of the sports event or the personal and material safety of other people, objects that may distract the players, officials or may interfere with the spectators' entertainment, objects that can be used in violent acts, or the possession of which has been banned by a rule of law, or the bringing of which to the sports event has been prohibited by the organiser;
 - banners or flags or symbols of tyranny that are prohibited by law and that incite hatred towards others, that have a political content or shock others, and he is not wearing such clothing;
 - any promotional or commercial purpose objects, unless he has a relevant permit issued by the organiser;
 - a video camera or professional camera, unless he has a relevant permit issued by the organiser;
 - any inscription, flag, banner indicating the support of sports organisation or national team not participating at the current match, and he is not wearing clothing that would convey a unanimous message of such affiliation;
 - \circ any animals, with the exception of guide dogs in the case disabled spectators;
- **2.8.** he acknowledges that during the sports event video and audio recording can be made about him (the recordings can be used or disclosed by the organiser, contracted parties and the accredited photographers for their own purposes);
- **2.9.** he does not exhibit any conduct prohibited in accordance with Sections 4 and/or 5 and/or 6.

3. At the entrance the security staff must, while the police may search visitors' clothing and belongings. At the entrance the security staff can check the personal identity of the ticket or season ticket holder, and can compare (shall compare when ordered to do so by the police) the details shown on the ticket, season ticket or club card with the details contained in the document suitable for personal identification.

If the ticket or season ticket holder's personal details do not match the details shown on the club card, ticket or season ticket, admission will be denied.

- **4.** The participant:
 - **4.1.** The participant's clothing and belongings can be searched, his identity can be checked, he himself can be retained or ejected from the event by the police and the security staff securing the event;
 - **4.2.** In addition to the personal belongings and the items specified in the Ground Regulations, participants may carry only the official country flags of the teams and the official club flags of the clubs playing the match (with a maximum size of 1.5 m x 1.5 m); The national flags may only show the names of the official towns of the country, any other banner or flag exceeding the size limitation may be carried in and choreography may be displayed only with the organiser's permission;
 - **4.3.** The participant can exclusively
 - enter the premises of the sports facility through the entrance gate specified on the ticket, season ticket or invitation card;
 - access his sector or his place of work via the specified route;
 - occupy the seat and use the facility objects and catering units specified on his ticket/season ticket or invitation card;
 - **4.4.** The participant can only stay in the sector or location shown on his ticket, season ticket or other entry permit;
 - **4.5.** The participant must comply with the provisions of the Ground Regulations, the requirements specified by the organiser, as well as the instructions of the organiser, the police and the security staff, the requests of the stewards;
 - **4.6.** Unless instructed otherwise by the organiser, the security staff or the police, the participant can leave the sports facility only at the point of entry;
 - **4.7.** The participant may transfer his ticket, season ticket or his voucher entitling their receipt and entry permit issued in his name exclusively in the manner preliminarily announced by the organizer; the participant may not transfer his club card to another person;
 - **4.8.** once the participant has left the sports event and the admission ticket, season ticket or other certificate of admission grants the right for a single entry, he cannot return;
 - **4.9.** the participant shall leave the event when ordered to do so by the organiser, the organiser's representative or the security staff.
- **5.** During the sports event the participant shall not:
 - **5.1.** engage in any activity that disturbs the order of the sports event, prevents or may prevent the implementation of the sports event, or compromise the personal and material safety of the participants of the sports event;
 - **5.2.** throw objects to the playing field, to areas closed to spectators and in the direction of other persons without a prior permission of the organiser;
 - **5.3.** enter or shall not attempt to enter the playing field and other areas closed to spectators without a permit;
 - **5.4.** use pyrotechnic devices, shall not start a fire;
 - **5.5.** use laser pointers or similar signalling lights;
 - **5.6.** disturb the playing of national, official or competition related anthems;
 - **5.7.** stand on the escape route (e.g. on the stadium stairs) shall not obstruct, and shall stay clear from the escape routes, corridors, entrances, emergency exits, shall not obstruct the movement of vehicles and pedestrians;
 - **5.8.** demonstrate racist, xenophobic, indecent behaviour or behaviour that can be interpreted as one having an ideological, religious or political motivation, furthermore he shall not display slogans or emblems with such contents;

- **5.9.** affix any banner or flag on any fence, railing or pole without the organiser's or security staff's permit;
- **5.10.** obstruct the view of others;
- 5.11. climb on the fences or other structures of the facility;
- **5.12.** stand on the seats;
- **5.13.** cover his/her face (unless stipulated otherwise by law due to health reasons)
- **5.14.** litter, and shall obey the smoking related rules;
- **5.15.** pursue any commercial activity unless he is in possession of a prior written consent of the organiser;
- 5.16. may transmit information about the sports event or its result and moments only with a prior
 written consent of the organising sports federation or pursuant to a contract concluded with
 Szerencsejáték Zrt, including mainly information transmitted to sports betting and online sports
 betting organisers and sports betting data providers and their sub-contractors as well as recordings
 of the event representing rights and titles. If the participant cannot present a written permission
 of the organiser at the venue, he may be ejected following an order.

6. The organiser shall call the participant who jeopardises the implementation of the sports event as well as the personal and material safety of others, or who demonstrates conduct prohibited by law and/or the ground regulations or otherwise contrary to sportsmanlike cheering and encouragement to stop demonstrating such conduct.

7. If during the sports event a participant or any party requesting admission fails to meet the requirements specified in Sections 2 and/or 4 and/or 5, or fails to stop the behaviour referred to in Section 4-6 6 despite the security staff's warning, admission shall be denied and he shall be ejected from the sports event. The security staff shall order the person to be ejected to prove his identity. If the person to be ejected fails to obey the order, the security staff shall – in the absence of legal provisions to the contrary – immediately call the police to conduct an identity check. Until the arrival of the police, but maximum until the end of the third hour from the notification of the police, the security staff has the right to retain the person to be ejected, provided that the person is retained in an area covered by a surveillance camera system in operation on the site. The organiser is also entitled to retain the person if it is required for the preparation and communication of the decision to ban the retained person in accordance with Article 73 of the Sports Act.

8. If someone has been ejected from a sports event, or who was not ejected because an intervention by the organiser (security staff) at the venue of the sports event was thought to provoke actions by the spectators that would have disproportionately compromised the safety of the sports event, the organiser may ban such person from attending the sports events. Anyone who violates the Ground Regulations in any other way may also be excluded.

9. Anybody who resists by violence or threats a legal action taken by the police or security staff for maintaining the order, anybody who enters or attempts to enter an area closed to the spectators or a certain group of spectators, or throws to this area an object that may cause bodily injury, commits a crime, and may be banned from attending the sports event by the organiser.

10. The organiser may deliver the decision on ban to the e-mail or postal address provided by the participant during the purchase or obtainment of the ticket, pass or other proof of entry.

The organiser shall deliver the decision on ban primarily to the e-mail address provided by the participant during the purchase or obtainment of the ticket, pass or other proof of entry. A decision thus forwarded to the participant shall be deemed to have been delivered on the workday subsequent to forwarding. The decision on ban shall take effect on the workday subsequent to forwarding the communication to the specified electronic mail address even if the involved participant has not notified the change or termination of his/her email address. The organiser shall not be held liable in any way if the participant fails to check his e-mail address provided. The exclusion decision is enforceable from the workday subsequent to forwarding the decision on ban.

If the organiser does not have the participant's email address, the decision on ban will be delivered by registered mail to the postal address provided when purchasing or obtaining the ticket, pass or other proof of entry. Participants shall notify the organiser of any address change within five workdays.

The organiser is not liable if

- the address specified as above is incorrect or inaccurate;
- the participant's address has changed but the participant has failed to notify the organiser thereof.

The decision on ban forwarded by the organiser to the address available as described above shall be deemed to have been delivered on the 5th day subsequent to forwarding, even if it is returned to the organiser undelivered for any reason.

The participant may appeal to the court against the organiser's decision on banning him/her from attending the sports event.

11. For any infringement or damage resulting from a breach of the safety regulations and/or the ground regulations, the spectator is liable to pay damages in accordance with the regulations of the Civil Code and to pay compensation in accordance with the general rules on Liability for damages. If more than one spectator is involved in a breach of safety regulations or the ground regulations, they are jointly and severally liable. Liability for damages does not affect the spectator's infringement or criminal liability. The perpetrator of criminal damage shall indemnify MLSZ for all costs arising from the damage.

12. The organiser shall make sure that objects that cannot be taken to the premises pursuant to the Ground Regulations, but can otherwise be lawfully held, and do not contradict the spirit of sportsmanlike cheering, as well as objects exceeding the permitted dimensions are taken over in a documented manner, are stored safely and are returned when their owners leave the premises. If the owner fails to enter for collecting the objects that cannot be taken to the premises within one week following the end of the sports event, the organiser is not obliged to ensure its custody any further and the owner of the object or any other person may no longer make any claim, whether pecuniary or non-pecuniary, against the organiser. Food and drinks shall neither be taken over for custody.

13. During a sports event organised in a tournament system not falling within the scope of Government Decree 54/2004. (III. 31.) on the security of sports events on the safety of sport events and during a sport event or ordinary or enhanced security risk a representative of the organiser or, when employed, the Security Service and representative of the travelling sports organisation shall have the right and, during a sports event of enhanced or outstanding security risk in terms of football, an obligation, to monitor the public areas taken by fans in the stadium and waiting to be authorised to enter and in car parks designated for spectators, and to observe the participants with cameras that record images and sound with sufficient quality that facilitate the identification of participants (including biometrical identification capability) as well as to record the footages in order to guarantee the safety and security of participants and their belongings as well as for the identification of the perpetrator of actions infringing the preliminarily specified ground regulations constituting the basis of banning procedure for conducting the banning procedure in accordance with Article 73 of the Sports Act and the subsequent procedures, which cameras are installed at locations defined in a number established by the police or attached to the body of the organiser or, when security staff is employed, to the body of the security guards and to use the footages for purposes specified in this paragraph and handle them for 60 days subsequent to the sports event.

14. The organiser has taken out liability insurance for the participants. In the case of such events the availability of liability insurance is shown on the tickets and season tickets too. Only personnel lawfully attending the event may be eligible for liability insurance. In view of the provisions of the Sports Act, according to which the personal data registered during admission shall be erased immediately after admission or the denial of admission, apart from the exceptions specified by law, the right to insurance may be granted by the organiser only to those individuals who submit their respective claim by 12.00 a.m. of the

third day following the expiry of the validity of the admission ticket, season ticket or other certificate granting the right of admission (end of the match) in writing, by submitting the serial number of the admission ticket, season ticket or certificate granting the right of admission. With respect to that, the organiser recommends that the organisers are informed of any injury/claim during the match.

15. In order to ensure that spectators can leave the stadium in a safe manner, the police may keep the spectators in the sports facility until the groups of spectators of the opposing team leave the sports facility, the area secured by the police as well as from the fans' movement routes. If the police is not present at the sports event, the security staff may also decide on holding back spectators on their own.

16. If the sports event was cancelled or was held behind closed doors or in front of a limited number of spectators, the price of the ticket will be refunded within three working days. If the sports event is interrupted, the tickets and the season tickets – provided season tickets have been sold – shall be valid for the repeated event. The MLSZ representative shall make the refund

- electronically to customers who purchased the admission ticket online,
- to the person presenting the admission ticket at the point of sale when the ticket was purchased at a different point of sale.

17. During the sports event the security staff and the stewards shall continuously monitor compliance with the Ground Regulations.

18. For these Ground Regulations the following definitions shall apply:

- **18.1.** Organiser: In the case of matches played by national football teams, the Hungarian Cup Final and other sports events organised by it the Hungarian Football Federation. As a general rule, these Ground Regulations apply only to these matches and not to matches of football clubs.
- **18.2.** Participant: the natural person who stays at the venue of the sport event in the course of its duration. Spectators (fans) are regarded as participants.
- **18.3.** Organiser: Persons with a minimum qualification of "security guard" that are employed by the security company hired to secure the event, and whose clothing allows them to be identified as security staff.
- **18.4.** Steward: The organiser may employ stewards for performing the tasks relating to the organisation of the sports event as volunteers or under an employment contract or a contract for other legal relationship involving work. As a representative of the organiser, a steward especially assists in the communication with and providing information to the spectators and other participants at the venue of the sports event, in accessing the venue of the sports event and orientation inside, in the secure implementation of the sports event and in the use of the services provided at the venue of the sports event. Pursuant to the Sports Act only individuals over the age of 18 and with no criminal record may be employed as stewards.
- **18.5.** Sports event: a competition or match held for the pursuit of a sports activity in or outside a competition system by a sports organisation or sports federation in the presence of participants. A sports programme shall be regarded as a sports event. For the purposes of these Ground Regulations only a competition or match organised by MLSZ is a sports event.
- **18.6.** Duration of the sports event: from the arrival of the participants at the venue of the sports event up until they leave the venue of the sports event.
- **18.7.** Venue of the sports event: a public location or a specific part of the public area where the sports event is held and where spectators may be present.
- **18.8.** Sports facility: a structure and site providing the venue for an organised sports event.
- **18.9.** Exclusion: Pursuant to the Sports Act during a sports event organised by the organiser or with the involvement of a travelling sports organisation and during the use of the admission system the organiser shall refuse to sell admission tickets to individuals ejected from the sports event and shall prevent the attendance of the sports event by such persons (exclusion). The travelling sports organisation and the organiser may exclude from the attendance of the sports event anyone who has been ejected from a sports event, or who was not ejected because an intervention by the

organiser (security staff) at the venue of the sports event was thought to provoke actions by the spectators that would have disproportionately compromised the safety of the sports event.

This information is based on the provisions of the law but is not intended to provide exhaustive information about them. Other rules pertaining to the sports event and the participants are included in the Sports Act, our regulations available at our web-site <u>mlsz.hu</u> at website <u>meccsjegy.mlsz.hu</u> and in our Data Management Guide available at <u>adatvedelem.mlsz.hu</u>.
